If owners do not have an Iowa Registered ID number reported to IaHHA before March 15, 2026, owners need to put that horse(s) on another nomination form with the late payment included by April 15, 2026. Without the ISF#, that horse will not be eligible to Iowa Registered racing. No Nomination payments will be refunded. Please note that any form not filled out correctly, will be returned to get the proper information. You also run the risk that it will not get back in time for the deadline, so be very thorough the first time.
