# How to register your Stallion, Mare & Foal in the State of Iowa.

***Applications that need to be filled out if your are wanting to register a Stallion in the State of Iowa to make his offspring eligible for the Iowa Sires Stakes program.***

**Application for Eligibility Iowa Registered Stallion**, this application will have to be sent in along with \$30.00. An identifier in your area will come out and inspect that the stallion is in fact in the state.

**Stallion Status Report**, this application will have to be filled out if there is any changes with the Stallion standing in Iowa. Whether it be owner transfer, moved out of state, or passed away.

**Stallion Transfer of Ownership Form**, this application will have to be filled out if you are selling your Stallion but this Stallion is still standing within the state. The costs of this transfer is \$30.00 and the stallion will have to be inspected at the new location where they will be standing.

**Record of Mares Bred**, this application will need to be filled out for each stallion and will have to list every mare that was bred. This application is due September 1st of every year.

**BROODMARE REGISTRATION APPLICATION**, this application will have to be submitted when a new broodmare is purchased and will be foaling in the state. There is a \$30.00 fee that will be when the application is submitted. There are certain guidelines that will need to be met:

\*\*\*Eligibility for broodmare residency shall be achieved by meeting at least one of the following rules:

1. Thirty days' residency until the foal is inspected by a department inspector, if in foal to a Registered Iowa Stallion.
2. Thirty days' residency until the foal is inspected by a department inspector, for broodmares which are bred back to registered Iowa Stallions.
3. Continuous residency from December 31 until the foal is inspected by a department inspector if the mare was bred by other than an Iowa registered stallion and which is not bred back to an Iowa registered stallion.

The one-time broodmare registration will cover the mare her entire productive life as long as there is not a change of ownership (at which time a mare transfer form must be completed) and she meets the aforementioned eligibility rules.

**ALL MARES MUST BE REGISTERED PRIOR TO FOALING. MARE AND FOAL MAY NOT LEAVE THE STATE OF IOWA UNTIL INSPECTED BY A DEPARTMENT INSPECTOR.**

**MARE STATUS REPORT**, this application will be filled out every foaling year for the mare, there is no fee for this application but guidelines listed below:

***IMPORTANT:***

- This form must be received **PRIOR TO FOALING** for your expected foal to be eligible for the Iowa Breeder's Fund.
- This report must be received by Dec. 31 of the year conceived for the mare to meet the Dec. 31 residency requirements.

1. The above mare must foal in the State of Iowa for that foal to be eligible for registration in the Iowa Horse Breeders fund program.

2. Other requirements are:

A. Thirty days' residency until the foal is inspected by a Department inspector, if in foal to a registered Iowa Stallion.

B. Thirty days' residency until the foal is inspected by a Department inspector for broodmares which are bred back to registered Iowa stallions.

C. Continuous residency from December 31 until the foal is inspected by a Department inspector, if the mare was bred by other than an Iowa registered stallion and is not bred back to an Iowa registered stallion.

***NOTIFY THE OFFICE IMMEDIATELY IF YOUR MARE CHANGES LOCATION.***

**MARE TRANSFER OF OWNERSHIP FORM**, this application will need to be filled out if the mare is being sold within the state. A \$30.00 application fee is due with application.

**APPLICATION FOR IOWA-FOALED STATUS**, this application has a \$30.00 fee and you will need to send in your USTA registration papers along with the application for them to stamp their Iowa Registration number on the USTA registration paper.
